Subject: Assigning the charge of Project Manager Hydraulic Kashmir and PM JKPCC/EOC/R&B Works Kashmir.

Whereas the post of Project Manager Hydraulic Kashmir has been vacant since May 2021.

Whereas the matter has already been taken up with the government for posting/deputation of Superintendent Engineer Hydraulic to PIU ERA Kashmir.

Whereas the matter has again been taken up with the government latest vide Letter No. JTFRP/DT/22/K/966-68 dated 04.04.2022.

Whereas JTFRP has very stiff physical and financial targets and is being monitored at the highest level in the country since the project being part of Prime Ministers Development Package.

Whereas it is imperative for the smooth function of the project and to meet the strict deadlines and incremental targets laid down by the DEA, GOI and World Bank in successive Tripartite Review Meetings.

Whereas Mr. Zahoor Ahmad Shah, PM-T was given the charge of PM-Hydraulic-Kashmir as temporary internal arrangement and the officer has retired on superannuation on 31.03.2022.

Whereas till date the Government has not posted an officer to JKERA on the said post.

Now therefore as a temporary measure and without conferring any special right/privilege upon any officer in promotion/regularization/arrears, the charge of Project Manager Hydraulic PIU-ERA Kashmir is assigned to Mr. Ishtiaq Ahmed Malik, Project Manager Transport Kashmir, in addition to his own duties.

This arrangement is purely for effective and efficient implementation of the project and shall immediately cease as soon as the Government of J&K posts an Officer to this position.



Further, Mr. Ishtiaq Ahmad Malik shall also look after the charge of Project Manager JKPCC works, EOC and R&B works.

This order shall have immediate effect.
